Core tasks

The asset manager

- keeps track of the development of new products for the benefit of (institutional and private) clients;
- assess new products and, if desired, introduces them into existing investment portfolios;
- follows and interprets (numerical) information on companies, sectors, stock exchanges, economies, etc. in order to optimize investment portfolios;
- monitors and interprets international developments in the political, economic and social fields and forms an opinion on the possible effects on price formation;
- interprets forecasts of financial and economic developments at home and abroad against the background of history;
- takes stock of the circumstances of clients (asset size and composition, income, tax and family situation);
- identifies investment objectives, starting points, time horizon, possibilities and risk profile of the clients;
- draw up investment plans for (possible) clients, tailored to the investment policy and the risk profile of the client;
- independently sets up investment portfolios, negotiates conditions and rates within its competence, concludes agreements, monitors positions taken;
- be able to apply common performance measures and risk models to the managed portfolios;
- informs himself, where appropriate, of the reliability of unknown banks, commission agents, brokers, etc.;
- can apply the legal framework and (tax) regulations adequately and quickly in the varied and sometimes exceptional situations that may arise in daily practice;
- can translate 'duty of care' into daily practice.

- has knowledge of products (financial instruments) and their characteristics, options and futures market;
- knows the value of these products plus the factors that express and influence them; knows the basic principles of 'fundamental analysis' and 'technical analysis';
- knows quantitative methods and techniques;
- is familiar with portfolio theories;
- knows the market organization, the organization of trade and channels through which transactions are concluded;
- knows how transactions are administered, guaranteed and settled;

- broadly knows the macroeconomic variables that affect trading in securities, options and futures;
- assess developments in international and financial markets;
- may weigh variables, including in view of current events, in relation to the portfolios it manages;
- assesses reports from investment analysts and/or independent bodies on the basis of financial ratios;
- knows the risks of the various investment options for the long and short term;
- knows the coverage instruments;
- can estimate the value of the positions in a substantiated manner in the event of changed market conditions;
- is familiar with common performance measures;
- has knowledge of methods and models for drawing up investment strategies for the various client groups;
- knows how investment portfolios are administered;
- knows parties in the market;
- knows which actions are prohibited by law or code of conduct and why;
- knows the trading rules of the exchange on which it operates and can indicate when data is out-of-regulation;
- is aware of tax regulations;
- knows what 'duty of care' means in relation to current practice.
